Membership Classifications:

- Student - Fee, there is no cost for a student membership
  - This level is open to all students enrolled in a course of study for water, wastewater or environmental programs.
  - This is not a voting position
- Individual – Fee is \$15.00 per year.
  - This level is open to any person that is an operator in the water or wastewater field, including managers of a water or wastewater organization.
  - This is a voting position.
- Utility – Fee is \$30.00 per year.
  - This level of membership is open to any public or private water or wastewater Utility. This includes owner operated facilities and contracted groups that operate a Utility. All operators and managers of the Utility are eligible for this level of membership. The Utility must provide a list of the individuals associated with the Utility along with their dues payment. Individual members of the Utility can be added and removed during the year by submitting the changes to the SOOS Secretary/Treasurer.
  - These are voting positions for all of the operators and managers included in the list.
- Corporate – Fee is \$50.00 for general membership, \$100.00 for a sponsoring membership.
  - This level of membership is open to any Engineering firm or Equipment supplier. The corporate member may include a list of individuals associate with the firm that they wish to be included as members. Corporate individual members can be added and removed during the year by submitting the changes to the SOOS Secretary/Treasurer.
